Members, I refer with profound sorrow to the passing away of Ayatollah Akbar Hashemi Rafsanjani, former President of the Islamic Republic of Iran; Sir James Richard Mancham, the founding father and first President of Seychelles; and, Mr. Alexander M. Kadakin, Ambassador of the Russian Federation to India.

Ayatollah Akbar Hashemi Rafsanjani passed away on the 8th of January, 2017. A statesman and reformist, he initiated economic liberalization and development of the country. He also contributed

significantly to the strengthening of the Indo-Iranian relationship. His demise is an irreparable loss to Iran and its people.

Sir James Richard Mancham passed away on the 8th of January, 2017, at the age of 77 years. A great patriot, his contribution to the independence struggle of Seychelles and its subsequent political and economic development will always be cherished by the people of his country.

A legal practitioner, he served as the legal adviser to the Imphal Municipality and as a lecturer in the L.M.S. Government Law College, Imphal. He also served in the Manipur Bar Association for many years as its General Secretary, Vice-President and President. He was associated with students' organisations and the People's Union for Civil Liberties and worked for the empowerment of women in society.

Shri W. Kulabidhu Singh represented the State of Manipur in this House from June, 1990 to April, 1996.

In the passing away of Shri W. Kulabidhu Singh, the country has lost an able parliamentarian and a dedicated social worker.

Shri Hamid Ali Schamnad passed away on the 6th of January, 2017, at the age of 87 years.

Born in January, 1929, at Kasaragod District of Kerala, Shri Schamnad was educated at the St. Aloysuis College, Mangalore and the Law College, Chennai.

An advocate by profession, Shri Schamnad practised at the Kasaragod Bar. He was actively engaged in social service activities right from his student days and worked for the upliftment of the weaker and downtrodden sections of the society. He served as the Vice-Chairman of the Finance Enterprise Corporation and as a Member of the Senate of the Universities of Kerala and Calicut.

Shri Schamnad started his legislative career as a Member of the Kerala Legislative Assembly in 1960 and was a Member of that Assembly from 1960 to 1964.

Shri Hamid Ali Schamnad represented the State of Kerala in this House for two terms - from February, 1970 to April, 1973, and again from April, 1973 to April, 1979.

In the passing away of Shri Hamid Ali Schamnad, the country has lost an able parliamentarian and a dedicated social worker.

Dr. Mohd. Hashim Kidwai passed away on the 10th of January, 2017, at the age of 95 years.

Born in March, 1921, at Lucknow in Uttar Pradesh, Dr. Kidwai was educated at the Lucknow Christian College and the Lucknow University.

A freedom fighter, Dr. Kidwai actively participated in the Freedom Movement during his student days.

MR. CHAIRMAN (CONTD.): He started his career as a lecturer in the Department of Political Science at the Aligarh Muslim University in 1948 and went on to become a Reader in 1961. He was the Founder of the U.P. Nationalist Muslim Students' Federation. He also served as the

President of the Aligarh Muslim University Teaching Staff Association and as a Member of the Court of Aligarh Muslim University.

Dr. Kidwai was a prolific writer and has many publications on the freedom struggle and various streams of political thought to his credit.

Dr. Mohd. Hashim Kidwai represented the State of Uttar Pradesh in this House from April, 1984 to April, 1990.

In the passing away of Dr. Mohd. Hashim Kidwai, the country has lost a veteran freedom fighter and a distinguished parliamentarian.

Shri Ramdas Agarwal passed away on the 26th of January, 2017, at the age of 80 years.

Born in March, 1937, at Jaipur in Rajasthan, Shri Agarwal was educated at the Jaipur Maharaja College, Rajasthan.

A businessman by profession, he was associated with various chambers and associations of mining and trading organizations.

Shri Ramdas Agarwal represented the State of Rajasthan in this House for three terms - from April, 1990 to April, 1996, from April, 1996 to April, 2002 and again from April, 2006 to April, 2012. He was also the Chairman of the Department-related Parliamentary Standing Committee

on Industry.
