*Bills for introduction*

*The Compulsory Health Insurance for Senior Citizens, Mentally Retarded Children and Disabled Persons Bill, 2016.*

1. SHRI RAJKUMAR DHOOT to move for leave to introduce a Bill to provide for the compulsory health insurance for the senior citizens, mentally retarded children and physically disabled persons to be funded by the Government and for free of cost treatment of insured persons by all hospitals including private hospitals and clinics, etc., and for matters connected therewith and incidental thereto.

*The Youth (Eradication of Unemployment and Miscellaneous Provisions) Bill, 2016.*

2. SHRI AHMED PATEL to move that the Bill to provide for the protection and other measures to be undertaken by the Central and State Governments for the girl child and adolescent girls to save them from malnutrition, anaemia and various diseases afflicting them in Gujarat and other parts of the Country and for special provisions for nutritious meals supplemented by folic acid and multi vitamin tablets, timely health check-ups and medication free of cost and certain welfare measures to be undertaken by the State for the girl child and adolescent girls and for matters connected therewith and incidental thereto, be taken into consideration.
